To join Aetna Medicare Value Plus (PPO), you must:

- Be entitled to Medicare Part A
- Have Medicare Part B
- Live in the plan's service area, which includes the following counties: Oklahoma: Creek, Okmulgee, Rogers, Tulsa, Wagoner

What you should know

- Plan type: Aetna Medicare Value Plus (PPO) is a PPO plan. This is a Medicare Advantage plan that covers prescription drugs. You can use in-network and out-of-network providers. You will typically pay more for out-of-network care.
- Primary Care Physician (PCP): You have the option to choose a PCP. We recommend choosing a PCP because when we know who your doctor is we can better support your care.
- Referrals: Aetna Medicare Value Plus (PPO) doesn't require a referral from a PCP to see a specialist. Keep in mind, some providers may require a recommendation or treatment plan from your doctor in order to see you.
- Prior authorizations: Your provider will work with us to get approval before you receive certain services or drugs.

We have partnered with OTC Health Solutions (OTCHS) to provide this benefit. The benefit amount is not connected to a payment or debit card. You will use your Aetna Medicare Value Plus (PPO) member ID to confirm benefit eligibility, confirm available benefit amount, and make purchases. 	Review the formulary to make sure your drugs are covered.

	Effect on Current Coverage. If you are currently enrolled in a Medicare Advantage plan, your current Medicare Advantage healthcare coverage will end once your new Medicare Advantage coverage starts. If you have Tricare, your coverage may be affected once your new Medicare Advantage coverage starts. Please contact Tricare for more information. If you have a Medigap plan, once your Medicare Advantage coverage starts, you may want to drop your Medigap policy because you will be paying for coverage you cannot use.
	In addition to your monthly plan premium, you must continue to pay your Medicare Part B premium. This premium is normally taken out of your Social Security check each month.
	Benefits, premiums and/or copayments/co-insurance may change on January 1, 2025.
	Our plan allows you to see providers outside of our network (non-contracted providers). However, while we will pay for covered services, the provider must agree to treat you.
